

TERMS AND CONDITIONS FOR THURSDAY TRIVIA

1. Participation in this Promotion and information regarding redemption of any prize forms part of these terms and conditions. Participation In this **Thursday Trivia** (“Promotion”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in AEST local daylight savings time.
2. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
3. This Promotion commences on 13 June 2024 at 7.30pm and ends at 9pm, and continues every Thursday night at the same time thereafter until further notice (“Promotional Period”).
4. The Promoter reserves the right to vary the terms of, or cancel, this Promotion at any time without liability to any participant or other person, subject to applicable laws.
5. To enter the Promotion an Eligible Entrant must enter a Competition. To enter a Competition, Eligible Entrants must:
 - a) attend Grove Square- the Hills Food Court at the commencement of a Competition (the Promoter recommends arriving at least 10 minutes prior to the commencement of a Competition);
 - b) form a team consisting between two (2) to four (4) Eligible Entrants;
 - c) register their team name and number of team members with the trivia host prior to the commencement of a Competition in order to receive an answer sheet;
 - d) work with their team to answer a series of trivia questions on various topics provided by the trivia host within the time allowed by the trivia host (approximately 60 seconds). Each team must write their answers on the answer sheet provided to them during team registration. Teams will earn points for correct answers to trivia questions
 - e) submit their team’s answer sheet to the trivia host at the end of the Competition as directed by the trivia Host. Answer sheets will not be accepted by 3 minutes after Trivia Host requests all answer sheets be returned to them;
 - f) the team with the most points at the end of the Competition will win the Prize
6. An Eligible Entrant may only enter themselves and their team once per Competition. The Promoter takes no responsibility for late, lost or misdirected entries. Incomplete, illegible or incomprehensible entries will be deemed invalid.
7. During a Competition, your team must answer the questions supplied by the trivia host on your answer sheet and you must return your answer sheet at the conclusion of the Competition to the trivia host as directed.
8. The Promoter reserves the right to verify the validity of any Entry. The Promoter may, in its sole discretion, disqualify any entry from, and prohibit further participation in this Promotion by, any person who tampers with or benefits from any tampering with the entry process or with the operation of the Promotion and reserves the right to disqualify any entry which is not submitted in accordance with these conditions of entry.
9. The Promoter reserves the right, at its sole and absolute discretion, to deem any irregular entries, including entries that have not been completed properly as “Invalid Entries”.

10. Invalid Entries cannot win prizes.
11. This is a game of skill and chance plays no part in the determination of the winner.
12. For each Competition, there are three (3) prize level winners. The team with the most points accumulated from correct answers to trivia questions win 1st prize = \$100 hamper consisting of various selected products and/or store gift cards from Grove Square-The Hills, the team with the next highest amount of point will win the 2nd prize = \$60 hamper and the team with third highest points wins 3rd prize = \$40 hamper. For the avoidance of doubt the Prize is given to the team to be shared, and not on an individual basis.
13. Prizes are not transferable or exchangeable.
14. The Judge is the trivia host. The Judge's decision is final, and no correspondence will be entered. The Judge will select and announce Prize Winners at approximately 9pm at the conclusion of each competition.
15. At least one (1) member of the winning teams must be present to claim the prize at the time of announcement. If, despite its reasonable efforts, the Promoter cannot locate the Prize Winner or confirm a Prize Winner by 9:10pm on the respective night of the Judging from the Prize Winner, the Prize Winner forfeits the Prize and any element of the Prize will be forfeited and will not be transferable or redeemable for cash. If the participant is under the age of 18, the prize will be awarded to their parent or guardian.
16. If the Prize Winner forfeits the Prize pursuant to clause 15, the Judge will select the next highest scoring team of the Competition as the Prize Winner in the respective 1st, 2nd or 3rd prize tier ("Second Judging"). If required, the Second Judging will take place at the venue by 9:15pm the same day. The Promoter will take reasonable efforts to notify the Prize Winner as a result of the Second Judging in venue immediately after the Second Judging. If for any reason the Judges cannot reasonably locate a prize winner, this manner of judging will continue until a prize winner is found.
17. It is a requirement of entry into the Promotion that the entrant agrees that their personal information can be used in accordance with these Terms and Conditions, including for the purposes set out in clause 20.
18. The Prize is subject to the standard terms and conditions of individual product and service providers. The prize, or any unused portion of the prize, are not transferable or exchangeable and cannot be taken as cash.
19. There are Three (3) Prize Winners during the promotional period. The total prize pool is \$200.
20. All Participants consent to the Promoter using the Participant's name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this Promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.

The Promoter reserves the right, at any time, to verify the validity of entries and Participants (including a Participant's identity, age and place of residence) and to disqualify any Participant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
22. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to:- technical difficulties, unauthorised intervention or fraud, then the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any Entrant; or (b) subject to any

written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.

23. The Promoter's decision relating to the Promotion and/or redemption of the prizes is final and no discussions or correspondence with participants or any other person will be entered into.

24. Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("Non-Excludable Guarantees").

25. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (MINTUS INVESTMENTS PTY LTD ATF The Retail Investment Trust 4 trading as Grove Square - The Hills including their respective officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion, including (but not limiting): (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or correspondence that is late, lost, altered, damaged or misdirected (whether received by the Promoter or not) due to any reason beyond the reasonable control of the Promoter; (d) any variation in the prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by an entrant or winner; or (f) use of the prize.
